Department of Agriculture and Consumer Services

EOG Number: B2013-0022

Problem Statement:

Specific Appropriation 1467A of the Fiscal Year 2012-2013 General Appropriations Act provides \$1,059,200 in a Qualified Expenditure Category (QEC) for the Food Inspection Management System (FIMS) project. The FIMS project is to replace an obsolete desktop food safety system and a mobile electronic inspection system within the Department of Agriculture and Consumer Services.

The department began implementing the FIMS in the 2010-2011 fiscal year with funds within existing resources, and to date has expended a total of \$811,100 from state and federal trust funds. In order to continue the system development phase for the project, the department requests \$754,560 be released to cover the project's work plan for a six-month period. The associated costs relevant to this request include report development, data migration, and system documentation.

Pursuant to section 216.011(1)(ss), Florida Statutes, funds appropriated in a Qualified Expenditure Category must be transferred to operating categories for expenditure. To comply with this provision, \$754,560 must be transferred from the QEC category to the Contracted Services category to allow the department to continue the system development phase of the FIMS project.

Agency Request:

The Department of Agriculture and Consumer Services requests \$754,560 in the General Inspection Trust Fund be transferred and released from the Qualified Expenditure category – Food Inspection Management System to the Contracted Services category to replace an obsolete Food Inspection Management System.

Governor's Recommendation:

Recommend approval to transfer and release \$754,560 of appropriated funds from Qualified Expenditure category to Contracted Services category in the General Inspection Trust Fund to replace an obsolete Food Inspection Management System (FIMS).

Problem Statement:

The Florida Abuse Hotline serves as the central reporting center for allegations of abuse, neglect, and/or exploitation for children and vulnerable adults in Florida. The Hotline receives calls, faxes, and web based reports from citizens and professions with concerns of abuse, neglect, or exploitation on children and vulnerable adults in Florida. The Hotline assesses the information provided by the reporter and determines if the information provided meets statutory criteria for the Department of Children and Families (DCF) to conduct an investigation.

The FY 2012-13 General Appropriations Act appropriates \$4,500,000 to DCF in a Qualified Expenditure Category for the Abuse Hotline Transformation Project. This project will improve the Hotline's operations, processes, organization and technology to produce a more readable, complete, and standardized package of information for investigation. Of this appropriation, \$2,193,739 was appropriated for FY 2011-12 activities related to the procurement of project management and design. An additional \$2,306,261 was appropriated for FY 2012-13. This amendment requests the release of \$1,593,380 in budget authority from the FY 2012-13 appropriation to continue the implementation of software development, project review, and validation.

Agency Request:

The Department of Children and Families requests the release of \$1,593,380 in budget authority in the Operations and Maintenance Trust Fund from the Florida Abuse Hotline Redesign Qualified Expenditure Category within the Executive Direction and Support Services budget entity. Corresponding release of \$1,593,380 in double-budget authority is requested in the Working Capital Trust Fund in the Computer Related Expenses Category within the Information Technology budget entity so that DCF can transfer funds and make Abuse Hotline Transformation Project expenditures in the budget category designated for information technology projects.

Governor's Recommendation:

Recommend approval to transfer and release budget authority from the Qualified Expenditure Category - Florida Abuse Hotline Redesign category in the amounts of \$1,593,380 in the Working Capital Trust Fund to the Computer Related Expenses operating category within Information Technology and \$1,593,380 in the Operations and Maintenance Trust Fund to the DCF Data Center operating category within Executive Leadership to cover the redesign of the Florida Abuse Hotline and supporting business processes in accordance with 2012 General Appropriations Act proviso language and recommendations of the project feasibility study.

Problem Statement:

The Florida Safe Families Network (FSFN) is Florida's Statewide Automated Child Welfare Information System containing pertinent participant information including: historical abuse records, current placement information, medical information, missing children reports, photographs, family assessment, judicial review and management and performance reports. FSFN is utilized by the Florida Abuse Hotline, Child Protective Investigators, Community Based Care case managers, adult protective investigators, legal, licensing and the Department of Children and Families Administration.

The General Appropriations Act appropriated \$12,450,000 for Fiscal Year 2012-13 to fund programming changes to the FSFN system. The appropriation includes \$4,500,000 to make FSFN federally compliant. The programming changes include the requirements identified in the January 2011 compliance assessment completed by the U.S. Department of Health and Human Services Administration for Children and Families as not currently being in the FSFN system and needed in order to comply with all federal Statewide Automated Child Welfare Information systems (SACWIS) requirements. The remaining appropriation of \$7,950,000 provides funds for additional enhancements to FSFN to improve the flow and use of information among all parties responsible for the safety and well-being of a child. This amendment requests the first quarterly release of \$3,112,500 in budget authority from the FY 2012-13 appropriation to implement software development, project review, and training.

Agency Request:

The Department of Children and Families requests the transfer and release of \$3,112,500 in budget authority in various trust funds from the Child Dependency Redesign Qualified Expenditure Category within the Executive Direction and Support Services and the Family Safety and Preservation Services budget entities. Corresponding release of \$2,641,383 in double budget authority is requested from the Child Dependency Redesign Qualified Expenditure Category in the Working Capital Trust Fund to the Computer Related Expenses Category within the Information Technology budget entity to allow for the transfer of funds and make Child Dependency System Redesign Project expenditures in the appropriate budget categories.

Governor's Recommendation:

Recommend approval to transfer and release budget authority in the amount of \$5,753,883 from the QEC-Dependency System Redesign category in various trust funds (\$635,000 in the Federal Grants Trust Fund, \$1,500,000 in the Welfare Transition Trust Fund, \$490,000 in the Operations and Maintenance Trust Fund, \$487,500 in the Social Services Block Grant Trust Fund, and \$2,641,383 in the Working Capital Trust Fund) to operating categories in Executive Direction & Support Services, Information Technology, and

Family Safety & Preservation to make necessary modifications to Florida Safe Families Network and to complete the Child

Problem Statement:

For Federal Fiscal Year 2012, the U.S. Department of Homeland Security will award approximately \$339.5 million in grants through the Emergency Management Performance Grant (EMPG) Program to assist states in continuing to build an effective and consistent response to a threatened or actual disaster or emergency. Specifically, to help state and local governments sustain and enhance their catastrophic planning capabilities; promote comprehensive state, regional and local emergency planning efforts; and focus on all-hazards planning, including updating and maintaining hazard mitigation plans. A federal EMPG grant requires a 50 percent state cost share match (cash or in-kind). Cities and counties provide the necessary state match.

Florida's share of the 2012 EMPG grant funds is \$14,836,576. Local governments are projected to receive \$5,856,802 of this amount.

DEM does not have sufficient appropriation in the appropriate EMPG category to fully execute sub-grant agreements with the counties in the projected amount. This is a technical adjustment between two categories to the General Appropriations Act and results in a net zero impact.

Agency Request:

The Division of Emergency Management requests a transfer of \$3,466,858 in budget authority from the Grants & Aid State/Federal Disaster Relief Administration category within the Federal Grants Trust Fund to the Aid to Local Governments Disaster Prep Plan & Administration category within the Federal Grants Trust Fund. This transfer will ensure that the division will have the requisite budget authority to execute the projected amount (\$5,856,802) of sub-grant agreements with the counties.

Governor's Recommendation:

Recommend approval to transfer budget authority in the amount of \$3,466,858 in the Federal Grants Trust Fund from Grants and Aid State/Federal Disaster Relief Administration to the Aid to Local Governments Disaster Prep Plan & Administration for the US Homeland Security grant award through the Emergency Management Performance Grant (EMPG) Program.

Problem Statement:

Chapter 2012-135, Laws of Florida, as approved by the Florida Legislature and signed into law by the Governor, transfers responsibility of providing reemployment services for injured workers from the Department of Education (DOE) to the Department of Financial Services (DFS). In addition, the bill transfers responsibilities related to the Automated Reemployment and Medical System (ARAMIS) to the DFS. The bill also authorizes the DFS to contract with one or more third parties to administer training and education screenings, reemployment assessments, vocational evaluations, and reemployment services. These changes were effective July 1, 2012. On July 10, 2012, budget amendment EOG #B0055 was approved which provided funding to support the program for the first quarter of the fiscal year. This amendment requests the balance of the original amount needed to fund this program for the remaining three quarters of the 2012-2013 fiscal year.

The Department of Financial Services requests budget authority in the amount of \$2,323,780 (\$2,186,528 - Workers' Compensation Administration Trust Fund; \$137,252 - Administrative Trust Fund). This budget authority will be used to implement the injured workers' program provisions authorized in chapter 2012-135, Laws of Florida. The breakout of the DFS request is as follows: \$301,830 in other personal services; \$84,174 in expenses; \$974 in TR/DMS/HR outsourcing; and \$1,800,000 in purchased client services (new category) for a total of \$2,186,528 from the Workers' Compensation Administration Trust Fund in the Division of Workers Compensation. In addition, \$7,652 in expenses and \$129,600 in contracted services, for a total of \$137,252 from the Administrative Trust Fund in the Division of Information Technology.

Agency Request:

The Department of Financial Services requests an increase of \$2,323,780 in the Workers' Compensation Administration Trust Fund (\$2,186,528) and in the Administrative Trust Fund (\$137,252) in the other personal services, expenses, contracted services, TR/DMS/HR outsourcing, and purchased client services categories to support implementation of the transfer of the injured workers' program from the Department of Education to the Department of Financial Services.

Governor's Recommendation:

Recommend approval to increase budget authority by \$2,186,528 in the Workers' Compensation Administration Trust Fund in the Division of Workers' Compensation and \$137,252 in the Administrative Trust Fund in the Division of Information Technology, to implement Chapter 2012-135, Laws of Florida, and the transfer of the Injured Workers' Program from the Department of Education.

Department of Juvenile Justice

Problem Statement:

The Department of Juvenile Justice (DJJ) has submitted an application to the Department of Financial Services (DFS) for approval of a five year loan to purchase telecom and data equipment from Siemens through the Consolidated Equipment Financing Program (CEFP). DJJ will be utilizing some of their existing equipment at the North Florida Youth Development Center, which closed June 30, 2011. This upgrade will allow the department to replace the telephone equipment and the aging data network at their headquarters in Tallahassee, thus resulting in reduced telephone service costs. Pursuant to subsections 287.063 and 287.064, Florida Statutes, the loan is considered a deferred payment and must be paid from the Deferred-Payment Commodity Contracts appropriation category. This amendment infers a recurring budget need of \$59,032.

Agency Request:

DJJ requests the transfer of \$59,032 in General Revenue budget from the Expenses appropriation category to the Deferred-Payment Commodity Contracts appropriation category in the Executive Direction/Support Services budget entity for the installment purchase of telecom and data equipment through the Consolidated Equipment Financing Program (CEFP).

Governor's Recommendation:

Recommend approval to transfer \$59,032 in General Revenue funds from Expenses to Deferred-Payment Commodity Contracts within Executive Direction/Support Services for the installment purchase of telecom and data equipment through the Consolidated Equipment Financing Program (CEFP).

Department of Legal Affairs and Attorney General

Problem Statement:

In 1995 the Attorney General, Robert A. Butterworth filed an action against the defendant corporations pursuant to the Florida Racketeering Influenced and Corrupt Organized Act (RICO), specifically section 895.05(5), Florida Statutes. The Attorney General's Office position in bringing the RICO action was to exercise the police power of the state to prevent public harm. The circuit court granted a temporary injunction without bond. The Florida Supreme Court ultimately determined that violations of the bingo laws did not constitute predicate acts under the RICO Act. Accordingly, the trial court's entry of the temporary injunction was improper.

The defendant corporations thereafter obtained judgments in the circuit court for wrongful injunction damages against the Attorney General's Office, including attorneys' fees, as described below. Those judgments were affirmed by the 5th District Court of Appeals, which awarded additional attorneys' fees for the appeal in an amount to be determined by the circuit court.

On March 2, 2012, a circuit judge granted a Writ of Mandamus in the case of the State of Florida, Office of the Attorney General v. Bradenton Group, Inc. (Case No. 1995-CI-06890-O) ordering the Office of the Attorney General to pay the judgment of \$4,603,722.00 awarded on August 20, 2008 plus accrued interest. The interest for the period extending from August 20, 2008 to August 23, 2012 is \$2,031,390.49 for a total judgment of \$6,635,112.49.

Agency Request:

The Office of the Attorney General requests an appropriation of \$6,635,113 from the Legal Affairs Revolving Trust Fund to pay the final judgment in the case of the State of Florida v. Bradenton Group, Inc. in accordance with the circuit court order.

Governor's Recommendation:

Recommend approval to increase budget authority by \$6,635,113 in the Legal Affairs Revolving Trust Fund within the Office of the Attorney General to allow payment of the final judgment in Case No. CI95-6890, State of Florida v. Bradenton Group, Inc.

Problem Statement:

The City of Tampa has requested assistance from the Florida National Guard for security services during the 2012 Republican National Convention (RNC) being held there. The National Guard was asked to support local law enforcement with security and response to civil disturbance in various locations surrounding and within downtown Tampa from August 27-30, 2012. The Florida National Guard will also prepare to respond with additional security forces in the event that they are required by local law enforcement.

The City of Tampa is provided federal funds to support necessary security and other expenditures related to the convention. Of that allocation, \$1.29 million will be provided to support the Florida National Guard's security effort. In addition, \$1 million has been allocated by the National Guard Bureau of the U.S. Department of Defense. Additional budget authority is necessary to allow the expenditure of these federal funds.

Agency Request:

The Department of Military Affairs requests an increase of \$2,290,000 in the Salaries and Benefits (\$1,890,000) and Expenses (\$400,000) appropriation categories within the Military Readiness and Response budget entity from the Federal Grants Trust Fund to support the provision of security services for the Republican National Convention, occurring in Tampa in August 2012. The cash to support the increased appropriation will be supported from federal funds provided through the City of Tampa and the National Guard Bureau.

Governor's Recommendation:

Recommend approval to increase budget authority in the amount of \$2,290,000 in the Federal Grants Trust Fund from the Salaries and Benefits (\$1,890,000) and Expenses (\$400,000) appropriation categories to support the provision of security services by the Florida National Guard at the Republican National Convention in August 2012.

Problem Statement:

On March 28, 2012, Governor Scott appointed a state Chief Operating Officer to begin an enterprise-wide approach to improving agency productivity. Based on the enterprise-wide approach initiative, the Department of Management Services' (DMS) Purchasing Oversight program analyzed its internal capabilities and developed two strategic sourcing mechanisms to support an enterprise-wide initiative aimed at potentially reducing costs. An analysis of data from the Florida Accounting Information Resource System (FLAIR) resulted in \$3.8 billion in identified state spend from FY 2010-2011, which could possibly be sourced with state-term contracts.

Based on the FLAIR data, MyFloridaMarketplace (MFMP), and vendor reporting, purchases off statewide agreements are currently approaching one billion dollars. If the DMS were able to strategically source \$1.6 billion of the available opportunity through multiple state-term contracts, the department states the result could approach savings to the state of up to \$100 million over a 2.5 year period.

Another potential option is for the state to partner with a national purchasing consortium, who in turn would hire a consulting firm. This option would eliminate the need for up front funding. However, this approach has not previously been utilized. The national purchasing consortium option would have a nationwide contract that Florida purchases would go through in exchange for collecting administrative fees from the awarded suppliers.

The DMS has developed a two step action plan in an attempt to expeditiously increase sourceable spending. The DMS will seek the expertise of a third party consulting firm that specializes in strategic sourcing to identify opportunities through detailed analysis, prioritize potential sourcing events (new state-term contracts or existing contracts that should be rebid), and procure those contracts. This effort is projected to cost \$9 million for 15-20 contracts.

In order to undertake this initiative, the DMS requests an increase of \$3 million in the Contracted Services category in the Purchasing/ Operating Trust Fund to support this effort. The department requests that the \$3 million increase in budget authority be placed into budget reserve. If the consulting firm approach is chosen, the DMS will negotiate the number of sourcing events that can be supported and will request the release of funds and provide detail on the deliverables that will be provided. The DMS issued an Invitation to Negotiate (ITN) to both third party consulting firms and national consortia with evaluations currently in progress. A recommendation will be made in a public meeting on August 14th. Based on the current timeline, the negotiations commence August 21st and will

produce an award recommendation on October 22nd. Once the responses are received, the department will review to determine the best funding model.

The Legislative Budget Commission staff cannot validate the potential cost savings or the methodology utilized by the department to calculate the potential savings to the state as a result of the proposed amendment.

The \$3.0 million appropriation within the proposed budget amendment may have an adverse fiscal impact on the DMS Purchasing Oversight/ Operating Trust Fund to the extent that it may result in a shortage for necessary operations in FY 2012-13 and beyond. Based on the department's accrual fund balance analysis the projected cash balance of the trust fund at the conclusion of the FY 2012-13 will be \$5.6 million (based on estimated expenditures of Purchasing Oversight). However, the estimated cash balance does not take into consideration any projected transition costs for the MFMP System which the department has estimated to cost as much as \$6.0 million during FY 2012-13. The current year General Appropriation Act directs DMS to submit a plan for consideration by the Legislative Budget Commission for transition funds and any other operating appropriations related to the department's proposed plan and/or procurement of the MFMP System currently underway. The 2012-13 General Appropriations Act only provides funding for the MFMP contract through its expiration date of December 2012. It is anticipated that DMS will submit a plan for MFMP and the overall operation of Purchasing Oversight prior to December 2012. In addition, the \$5.6 million trust fund year-end balance assumes a significant savings in the re-procured contract for the MFMP System – otherwise the Purchasing/Operating Trust Fund balance will be further compromised.

Agency Request:

The Department of Management Services requests an increase of \$3,000,000 to be placed in reserve in the Contracted Services appropriation category from the Purchasing Operating Trust Fund within the Purchasing Oversight budget entity. The \$3 million increase is requested to support a contract for services that will include spend analytics, the identification of state-term contract opportunities, and subsequent procurement.

Governor's Recommendation:

Recommend approval to increase budget authority in the amount of \$3,000,000 in the Operating Trust Fund within Purchasing Oversight to support a potential contract for services that will include spend analytics, the identification of state term contract opportunities, and subsequent procurement with significant savings expected for the state. The department requests the budget authority be placed in reserve, to be released through a subsequent budget amendment.

Problem Statement:

Chapter 2010-161, Laws of Florida, directed the Department of Health to conduct an evaluation and justification review of each division established under s. 20.43, Florida Statutes. The review was to be comprehensive in its scope and, at a minimum, must be conducted in such a manner as to specifically determine whether the division and programs within the department could be administered more efficiently or effectively.

In response to Ch. 2010-161, Laws of Florida, the department conducted an evaluation and justification review and on March 1, 2011, submitted a report of its review findings and recommendations to the President of the Senate, the Speaker of the House of Representatives, the chairs of appropriate substantive committees, the Legislative Auditing Committee, and the Governor. Subsequently, HB 1263, passed during the 2012 Legislative session and approved by the Governor, gave further direction requiring the department to restructure its divisions and programs.

In accordance with HB 1263, this budget amendment provides for the realignment of budget appropriations, positions, and salary rate to reflect the departmental structure envisioned in the legislation. Additionally, HB 1263 requires the transfer of the Nursing Student Loan Forgiveness Program from the Department of Health to the Department of Education.

Agency Request:

The Department of Health requests the realignment of 1,004.5 FTE, 43.7 million in salary rate, and \$924.2 million in operating budget within the department. This action will realign the budget authority for Information Technology, Environmental Health Services, and Community Health Resources. The department also requests the transfer of 1.0 FTE, 46,560 in salary rate, and \$1.1 million in operating budget rate for the transfer of the Nursing Student Loan Forgiveness Program from the Department of Health to the Department of Education.

Governor's Recommendation:

Recommend approval of the transfer of 1004.5 FTE and approximately \$924.2 million in operating budget authority for the restructuring of the Department of Health and its divisions, and programs within divisions in a more efficient and effective manner; as well as the type two transfer, as defined in s. 20.06(2), Florida Statutes, of 1.0 FTE, 46,560 in salary rate, and \$1.1 million in budget authority in the Nursing Student Loan Forgiveness Trust Fund along with all powers, duties, and functions relating to the Nursing Student Loan Forgiveness Program and the nursing scholarship program to the Department of Education to comply with Chapter

Problem Statement:

The Department of Health (DOH), Bureau of HIV/AIDS (Human Immunodeficiency Virus/Acquired Immune Deficiency Syndrome) received an increase for the Ryan White Care Act II grant awarded by the U. S. Department of Health and Human Services. Budget authority is needed to support the increased award amount for Fiscal Year 2012-13.

The department requests \$4,754,507 in budget authority in the Federal Grant Trust Fund to support three primary goals: reducing the number of people in Florida who become infected with HIV; increasing access to care and optimizing health outcomes for people in Florida living with HIV; and reducing HIV-related health disparities. This award also grants funds to support AIDS insurance continuance allowing patients to continue their private insurance which is a cost savings to the state and direct patient care. The total Ryan White Care Act II grant for the federal budget period 04/01/12-03/31/13 is \$127,814,122.

Agency Request:

The Department of Health requests \$4,754,507 in budget authority in the Federal Grants Trust Fund within the Disease Control and Health Protection budget entity to implement the Ryan White Care Act II as follows:

\$629,712 in the Contracted Services category;

\$3,624,795 in the Grants and Aid AIDS Insurance Continuation Program category; and \$500,000 in the AIDS Patient Care category.

Governor's Recommendation:

Recommend approval to increase budget authority by \$4,754,507 in the Federal Grants Trust Fund in various categories for the Ryan White Care Act Type II federal grant.

Problem Statement:

Section 409.9082, Florida Statutes, creates a quality assessment on nursing home facility providers, which began in Fiscal Year 2009-10. The assessments collected are used to obtain federal financial participation through the Medicaid program to make Medicaid payments for nursing home facility services. The Department of Veterans' Affairs operates six state veterans' nursing homes that are subject to the assessment.

The Agency for Health Care Administration (AHCA) is responsible for implementing the quality assessment and collecting the appropriate assessment from each nursing home. The assessment is calculated monthly on a per-resident-day basis as determined by AHCA for days that are not funded under the federal Medicare program. The assessment rate has increased from \$15.89 in Fiscal Year 2009-10 to \$22.89 beginning in July 2012.

The change in rate from Fiscal Year 2009-10 to July 2012 represents an increase of \$7.00 or 44.1 percent. The Department does not have sufficient budget authority to remit the required quality assessment funds to AHCA.

Agency Request:

The Department of Veterans' Affairs requests an increase in expense budget authority in the Operations and Maintenance Trust Fund in the amount of \$3,749,383 to meet the requirements of section 409.9082, Florida Statutes, for the quality assessment fee for the six state veterans' nursing homes. This includes the increased rate and increased Non-Medicare resident days projected for Fiscal Year 2012-13, \$2,441,932 as well as the quality assessments for the months of April, May and June 2012, not paid in Fiscal Year 2011-12, \$1,307,451.

Governor's Recommendation:

Recommend approval to increase budget authority in the expense category, in the amount of \$3,749,383, in the Operations and Maintenance Trust Fund to pay the nursing home assessment fee for FY 11-12, \$1,307,451 and the projected increase in the rate for FY 2012-13, \$2,441,932.

Fish and Wildlife Conservation Commission

Problem Statement:

Chapter 2012-88, Laws of Florida, requires a type two transfer of law enforcement functions from the Department of Environmental Protection (DEP) to the Fish and Wildlife Conservation Commission (FWC) and authorizes the transfer of DEP administrative positions to FWC as needed to provide administrative support. The type two transfer of 146.5 DEP law enforcement full-time equivalent (FTE) positions was completed effective July 1, 2012 in budget amendment EOG B0039; however, the administrative positions still need to be transferred. The agencies have identified four DEP administrative positions needed to support the transferred law enforcement functions. These include two inspector general positions, one information technology position and one administrative services position.

Agency Request:

This budget amendment requests the transfer of 4.0 FTE positions, 185,148 in salary rate and \$237,545 in Administrative Trust Fund and \$45,695 in Working Capital Trust Fund from the Department of Environmental Protection Executive Direction and Support Services/Technology and Information Services to the Fish and Wildlife Conservation Commission Executive Direction and Support Services.

In addition, the FWC requests increased operating budget transfers of \$19,827 in Coastal Protection Trust Fund, \$45,319 in Inland Protection Trust Fund, \$157,815 in Land Acquisition Trust Fund and \$60,279 in Solid Waste Management Trust Fund from DEP to FWC to provide cash support for the transferred budget.

Governor's Recommendation:

Recommend approval to transfer budget authority in the amount of \$237,545 in the Administrative Trust Fund and \$45,695 in the Working Capital Trust Fund along with four administrative positions and 185,148 in associated rate from the Department of Environmental Protection (DEP) Executive Direction and Support Services/Technology and Information Services to Fish and Wildlife Conservation Commission's Executive Direction and Support Services; as well as requesting to increase authority by \$19,827 in the Coastal Protection Trust Fund, \$45,319 in the Inland Protection Trust Fund, \$157,815 in the Land Acquisition Trust Fund and \$60,279 in the Solid Waste Management Trust Fund within DEP to provide cash support for the transferred budget and to complete the Law Enforcement Consolidation pursuant to Chapter 2012-88, Laws of Florida.

Justice Administration

EOG Number: B2013-0028

Problem Statement:

During the 2012 session, Chapters 2012-124 and 2012-100, Laws of Florida, passed relating to the clerks of the court collection of fees and fines. The law requires imposition of mandatory monetary assessments mandated by law even if not pronounced in open court. As a result, the clerks will have more assessments available for collection. The law makes several changes to current law relating to the responsibilities of the clerks of the court to enhance the collection of court fees and fines and to improve the efficiency of clerks' operations. The bill also clarifies the law to assist the clerks in collecting outstanding debts owed to the state and will increase revenue resulting from the improved collection enhancement tools. The bill deletes the statutory requirement for the clerks to conduct certain indigency reviews which will provide more time for staff to enhance their collection efforts. The increase in collections by the clerks of the court will result in a positive fiscal impact. Therefore, the clerks of the court are requesting an additional \$29.5 million in trust authority in the Clerks of the Court Trust Fund.

In addition, Chapter 2012-119, Laws of Florida authorizes the clerks to retain any remaining moneys from the cash balance in the trust fund from the prior year. According to the Chief Financial Officer, the cash balance in the trust fund was \$13.3 million on June 30, 2012.

Without approval of this amendment, there would possibly be delays in the processing of civil cases, child support cases, final judgments of dissolution of marriages, orders and stipulations, foreclosure cases, landlord tenant eviction cases, and final judgments that will impact the business and legal community from obtaining financial payments and possession of real property.

Agency Request:

The clerks of the court are requesting an additional \$29,500,000 in budget authority in the Clerks of the Court Trust Fund to support the increase in revenue collections resulting from legislation in the 2012 session.

Governor's Recommendation:

Recommend approval to increase budget authority by \$29,500,000 in the Clerk of Courts Trust Fund to allow the Clerks to expend the prior year cash balance allowed to be carried forward under section 18, Chapter 2012-119, Laws of Florida; expend additional revenues expected by ensuring assessments mandated by law are imposed as per Chapter 2012-124, Laws of Florida; and expend additional funds collected through the implementation of changes to strengthen collection efforts as provided by Chapter 2012-100, Laws of Florida.

Problem Statement:

The Guardian ad Litem (GAL) goal for Fiscal Year 2012-13 is to transform its program to an all volunteer work force, referred to as the "Transformation 13". To accomplish this goal, the Guardian Ad Litem program will undertake an aggressive volunteer recruitment strategy by hiring volunteer supervisors to provide additional recruiting services to bring every office (except Miami where the goal is too large to accomplish in a single year) up to full utilization of all of the case coordinator resources as volunteer supervisors.

For Fiscal Year 2012-13, the legislature appropriated additional funding to the GAL in the Contracted Services appropriation category. However, to accomplish the goal of hiring volunteer supervisors, funding is needed in the Other Personal Services (OPS) category.

Agency Request:

The GAL is requesting the transfer of \$712,040 in budget authority from the Contracted Services category to the Other Personal Services category to provide the agency the flexibility to hire recruiting resources quickly, offer the agency the best opportunity to meet their goal and still build the required benchmarks for early success.

Governor's Recommendation:

Recommend approval to transfer \$712,040 in General Revenue funds from Contracted Services to Other Personnel Services in the Guardian ad Litem Program to provide resources for accomplishing goals of the number of volunteers and the implementation of "Transformation 13".

Problem Statement:

Florida's Office of Early Learning is charged with designing, developing and implementing the Early Learning Information System (ELIS), a centralized technology system that will support the administration of the state's School Readiness and Voluntary Prekindergarten Education programs to provide information for parents and service providers. To date, the project has completed the first three of seven planned design and development iterations and it is anticipated that the project will complete all remaining design, development and implementation phases in 2012-13.

During the first quarter of 2012-13, the project team will complete development for the first four of seven software iterations, including live demonstrations of completed ELIS components for subject matter expert review. Following live demonstrations, the project will begin system integration testing for the four software iterations, and continue design activities for iterations five through seven. Subject matter experts from Early Learning Coalitions will also begin preparation for user acceptance testing activities planned for the 2nd quarter of 2012-13.

In order to continue work on the project during the first quarter of 2012-13 and to pay for the contract deliverable associated with the completion of the design phase, the Office estimates that it will require approximately \$1.8 million of operating authority. To meet this need, \$1,530,006 will need to be transferred from the reappropriation of prior year funds in the Qualified Expenditure Category in Section 14 of the 2012-13 General Appropriations Act.

Agency Request:

The Agency requests a transfer of \$1,265,776 from the Child Care and Development Block Grant Trust Fund and \$264,230 from the Grants and Donations Trust Fund in the Qualified Expenditure Category - Early Learning Information System (ELIS) to operating categories in order to pay for contractual obligations associated with the project beginning July 2012.

Governor's Recommendation:

Recommend approval to transfer budget authority in the amounts of \$1,265,776 in the Child Care and Development Block Grant Trust Fund and \$264,230 in the Grants and Donations Trust Fund in the Qualified Expenditure Category--Early Learning Information System (ELIS) to operating categories to pay contractual obligations associated with the project beginning July 2012.
