**JOINT RESOLUTION by Ways and Means Committee; Leek; (CO-SPONSORS) Avila; Eagle; Fischer; Ingoglia; Metz (Compare SJR 1742) Supermajority Vote for State Taxes or Fees;** Proposes amendment to State Constitution to prohibit a state tax or fee from being imposed or raised except through legislation approved by two-thirds of each house of legislature; requires a state tax or fee imposed or raised to be contained in separate bill that contains no other subject.
