Purpose:

The purpose of the State Library Council is to advise and assist the Division of Library and Information Services on its programs and activities and to act as a bridge between the division and those involved with making policy and program decisions for local libraries. Membership:

The State Library Council consists of seven members appointed by the Secretary of State. Members are appointed for 4-year terms. At least one member of the Council must be a person who is 60 years of age or older and at least one member must be a person who is not, and never has been, employed in a library or in teaching library science courses. The director of the Division of Library and Information Services, also referred to as the State Librarian, serves without voting rights as the secretary of the Council.
