Vice Chair Baxley moved that the Committee accept staff recommendations for the municipalities and special districts on Lists 1 through 4, and direct staff to contact the Department of Revenue and the Department of Financial Services or the Department of Economic Opportunity, as appropriate, and direct them to proceed according to the provisions of Section 11.40(2), F.S.<sup>1</sup>

Staff shall notify all parties required to be notified by law regarding these entities.

He further moved that the Chair, with the consent of the Vice Chair, be permitted to delay action against the entities on Lists 1 through 3 if additional information is brought to their attention that should be considered in determining the effective date of the Committee's action. Staff shall deliver a copy of any such decision to the members of the Committee, the President of the Senate, and the Speaker of the House.

Staff shall continue to monitor the special districts on List 4.

Motion passed unanimously.

The Committee is expected to consider taking action against educational and local governmental entities that have failed to take full corrective action in response to repeat audit findings, pursuant to ss. 11.45(7)(j) and 218.39(8), F.S.

Chair Zika called on Debbie White, CPA, Chief Legislative Analyst with the Committee, to explain the lists of educational entities and local governmental entities with audit findings that have been reported in at least three successive audit reports.

Chair Zika entertained a motion to accept the staff's recommendations and also direct staff to send a letter to any entity for which the Auditor General reports uncorrected audit findings to the Committee for late-filed 2019-20 audit reports unless a response has been previously provided and it appears that the entity has taken corrective action, to the extent possible, using existing resources.

Senator Baxley moved the motion, and it was adopted unanimously.

<sup>&</sup>lt;sup>1</sup> Section 11.40(2), F.S., authorizes the Committee to: (1) For counties and municipalities, direct the Department of Revenue and the Department of Financial Services to withhold certain revenue, with withholding to begin 30 days after the agencies have received notification; and (2) For special districts, direct the Department of Economic Opportunity to file a petition for enforcement in the circuit court in Leon County or begin the process to declare the special district inactive for dissolution.

Chair Zika called on Kathy DuBose, Committee Coordinator, to provide the results of the audits of the lobbying firm quarterly compensation reports performed in 2021 and explain the revisions to the Guidelines.

Chair Zika entertained a motion to approve the draft Guidelines and allow staff to make technical and clarifying changes.

Senator Baxley moved the motion, and it was adopted unanimously.

#### Consideration of the Committee's report required by the Transparency Florida Act, s. 215.985, F.S.

At the October 14, 2021 meeting, staff of the Governor's Office and Department of Financial Services demonstrated the transparency websites and staff provided a summary of the draft report. Chair Zika provided an opportunity, after the meeting, for members to submit recommendations to be considered for the Committee's Transparency Florida report.

Representative Persons-Mulicka submitted a recommendation, and presented it at the meeting, to include additional information on the Florida Accountability Contract Tracking Systems (FACTS) or other appropriate State Transparency website. Chair Zika entertained a motion to include Representative Persons-Mulicka's recommendation. Senator Baxley moved the motion, and the recommendation was adopted unanimously.

Chair Zika also entertained a motion to approve the draft report and allow staff to make technical and clarifying changes. Senator Baxley moved the motion, and it was adopted unanimously.

## Presentation of the Auditor General's operational audit of the Florida Birth-Related Neurological Injury Compensation Association (NICA) and response from NICA

Joshua Barrett, Audit Manager with the Auditor General's Office, presented the Auditor's General's report number 2022-009 on the Florida Birth-Related Neurological Injury Compensation Association Operational Audit.

Jim DeBeaugrine (NICA Board Chair) and Melissa Jaacks (Interim Executive Director) also spoke in regards to the Auditor Report.

# Presentation of the Auditor General's operational audit of the Belle Glade Housing Authority and response from the Authority

Greg Centers, Deputy Auditor General with the Auditor General's Office, presented the Auditor's General's report number 2022-032 on the Belle Glade Housing Authority Operational Audit.

Belle Glade Housing Authority representatives present were Steve Weeks (Board Chair), Ramona Hyson (President/CEO of Nelson & Associates), and Greg Hyson (Vice President of Nelson & Associates). Mr. Weeks and Ms. Hyson responded to questions from the Committee Members.

Ed Chase, Intergovernmental Affairs Director, with Palm Beach County spoke briefly before the Committee regarding the Audit Report.
