## Installation Guide and Technical Support Information

### Introduction

Welcome to The Search & Browse Florida Law download. It consists of full-featured information databases that allow you to browse the publication collections, search, print, and copy/paste text.

**Important Note:** The Search & Browse Florida Law download will be installed on your hard drive. It is accessed using your browser, and no internet connection is necessary. There are no limitations on use, so you may download and install it on as many PC's as you like.

Browser: Best with Microsoft Edge (latest), Mozilla Firefox (latest), Google Chrome (latest).

### Installation Instructions

**Windows 11:** You must be signed onto your computer as the administrator to install the downloaded file. Prior to InstallShield opening, you will be asked to respond to a security dialogue box regarding the installation. This is a function of Windows.

**Previous Users:** You must UNINSTALL previous versions of The Florida Legislature Florida Law 20nn prior to installing a newer version. Follow uninstall instructions.

#### Installation Instructions:

1. Unzip the file. Locate the setup.exe file. Right-Click on the Setup.exe file and Select "Run as administrator". Then enter your credentials to proceed with the Install.
2. Read and respond to screens.
3. Install to the hard drive.
4. Once the installation has completed, click **Finish**. Open the application by clicking the icon on your desktop or from the Program Menu in the Start window.
5. Reinstallation—run Uninstall following the instructions below before reinstalling.

**Uninstall Instructions:**

1. To uninstall a previous version of Search & Browse Florida Law 20nn from your PC, type **Control Panel** in the Search bar at the bottom of the screen.
2. Click on **Control Panel**.
3. Click on **Programs**.
4. Click on **Programs and Features**.
5. Right click on **The Florida Legislature Florida Law 20nn** in the list of programs.
6. Click the **Uninstall** button. Uninstall will guide you through the entire process.
7. Uninstall does not remove ALL the files created. After running uninstall, manually delete the folder **C:\FLLaw20xx** from your hard drive.
